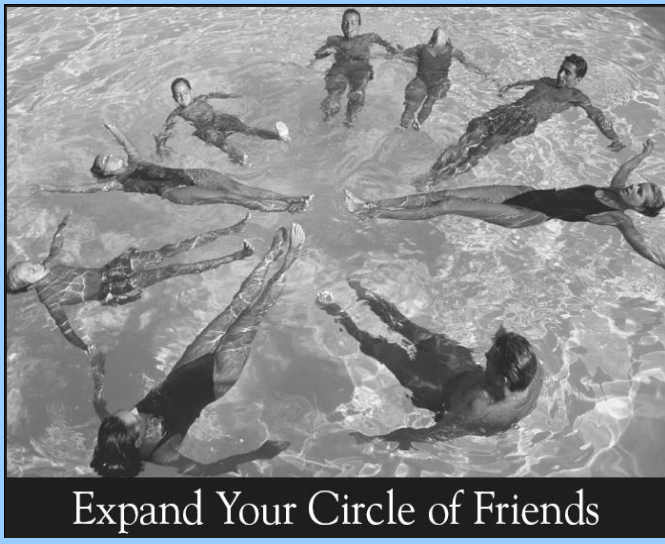


Holmes Run Pool – 2012 Overview Over 59 years of Community Service

The Holmes Run Recreation Association offers three sparkling pools in a lovely wooded, private park-like environment with picnic areas, grills, and recreational activities – right in your own back yard! It is a healthy and safe gathering place for the individuals and families of our community.

Our facility is a wonderful haven for summer activities: swimming, sunning, grilling, picnicking, aqua aerobics, and yoga. Enlist your kids in an energetic swim team, a positive experience for kids & adults! Or just relax and have some summer fun!

We offer various social events, movie nights and food festivals throughout the summer -- it is a place to meet your neighbors and enjoy your friends & family. Our friendly pool is a diverse community who welcome all. Hands down, we offer the very best value for your money among the surrounding community pools.

You will find us nestled at the bottom of a hill off Gallows Road, next to Woodburn Elementary, in a shaded wooded area that is sheltered from the noisy road traffic, yet still offering easy access to our parking area. Bordered by a large wooded area owned by the Fairfax Schools on two sides and by a quiet neighborhood on the remaining side, we are thankfully isolated from the intensity of the Washington Area. Started as one pool on a small plot of land in 1954 it now consists of a rather large and lovely shaded grounds; three pools; three decks and a patio; a large picnic area; two brick barbecue grills, various recreation facilities, two baths houses and more. We share a rich and vibrant history in the maturing of our surrounding neighborhoods and have contributed immensely to the quality of life of the individuals and families that have lived here. With your membership we can continue in that tradition.

The Holmes Run Recreation association is incorporated in the state of Virginia and is classified as a social non-profit organization for tax reporting purposes. The fees collected from our members pay 90 % of the monies required to fund our operational and maintenance costs with an annual budget of over \$115,000. For a minimal one-time cost, each new shareholder becomes an owner of extremely valuable property that continues to increase in worth. Every owner has a say in how the association is managed and what activities will take place. All members contribute in some small way to make our facility a better place.
